

ORDINANCE NO. 2, 2025

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICES AND SAFETY TO ENTER INTO AN AGREEMENT FOR VEHICLE LEASING WITH ENTERPRISE FLEET MANAGEMENT AND DECLARING AN EMERGENCY.

WHEREAS, the Village of St. Bernard ("Village" hereinafter) wishes to improve the fleet of service vehicles; and

WHEREAS, the Village wishes to manage the overall spend on fleet and fleet maintenance; and

WHEREAS, the Village desires to have the ability to lease such vehicles as a means of controlling such expenses; and

WHEREAS, time is of the essence due to significant lead time necessary for acquiring vehicles; and

WHEREAS, the Village desires to authorize the Director of Public Services and Safety to enter into a Master Equity Lease Agreement with Enterprise FM Trust; and

WHEREAS, the Village is authorized as a charter municipality to exercise all powers of local self-government. Now therefore,

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO


Section 1. That the Director of Public Services and Safety is hereby authorized to execute an Agreement and any other necessary documents on behalf of the Village to enter into a leasing arrangement with Enterprise Fleet Management.

Section 2. That because the Village must wait an extended period of time to take possession of vehicles due to long lead times from various manufacturers, this ordinance shall take effect immediately upon passage.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this legislation were adopted in open meeting of this Council; and, that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Revised Code Section 121.22.

Section 4. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is the time frame to enter into the agreement. Therefore, this resolution shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this resolution shall take effect on the earliest date provided by law if approved by no more than the majority of the members of Council and in that event the emergency provisions herein are set at naught.
